

Annual Rebalancing of MCX iCOMDEX™ Indices

In terms of the provision of the Rules, Bye-Laws and Business Rules of the Exchange, the Members of the Exchange are notified as under:

The annual rebalancing of MCX iCOMDEX™ Composite Index, MCX iCOMDEX™ Bullion Index and MCX iCOMDEX™ Base Metal Index shall be undertaken on the respective index's first rollover day in January 2020. The details of eligible index constituents and their weights in respective MCX iCOMDEX™ indices have been announced in the Notification section of MCX iCOMDEX page, under Market Data tab, on the MCX website.
