## Annual Rebalancing of MCX iCOMDEX® Indices for the Year 2025 – Announcement of Weights

---

In terms of the provision of the Rules, Bye-Laws and Business Rules of the Exchange and further to Exchange Circular No: MCX/Indices/692/2023 dated October 10, 2023, Members of the Exchange are notified as under:

The annual rebalancing of MCX iCOMDEX Bullion Index (MCX BULLDEX®), MCX iCOMDEX Base Metal Index (MCX METLDEX®), MCX iCOMDEX Energy Index (MCX ENRGDEX®), and MCX iCOMDEX Composite Index (MCX COMPDEX®) for the year 2025 shall be carried out in the month of January 2025 during the respective rollover days of the indices.
