To All Members,

Sub: Shifting of trading in Securities to Z Category

Pursuant to SEBI Circular No. SEBI/HO/CFD/PoD2/CIR/P/2023/120 dated July 11, 2023 (“Master Circular”), Members of the Exchange are hereby informed that the below mentioned Companies have been identified as non-compliant with Regulation 33 (i.e., Submission of Financial Results) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”) for two consecutive quarters’ i.e. March 31, 2024 and June 30, 2024. Details are as under: -

Therefore, trading in securities of the above-mentioned Companies shall be transferred to ‘Z’ (“BZ Series”) Category with effect from October 25, 2024, if these companies do not comply with Regulation 33 of the SEBI (LODR) Regulations, 2015 as per the provisions of Master Circular on or before October 22, 2024.

The below mentioned Companies have also been identified as non-compliant under Regulation 33 i.e., (Submission of Financial Results) of Listing Regulations for two consecutive quarters i.e. March 31, 2024 and June 30, 2024.

Hence, the trading in securities of these Companies is also eligible to be transferred to ‘Z’ Category (“BZ” Series) with effect from October 25, 2024, for the said non-compliance.
