Market Data – Extension of Discontinuation of Existing broadcast parameters in Futures & Options Segment

This is in reference to Exchange circulars [NSE/MSD/69181](#) dated July 18, 2025, and [NSE/MSD/69328](#) dated July 28, 2025 regarding introduction of new Broadcast Parameters for market data in Futures & Options Segment.

In the aforesaid circulars, the Exchange had announced enhancements to market data dissemination through new transcodes for Ticker and Market Index, Market Watch updates, Bhavcopy updates, and Underlying Open Interest and released the new parameters for receiving the broadcast in LIVE w.e.f July 21, 2025. Since then, Exchange has provided a coexistence phase for receiving broadcast from both existing and new parameters, after which Exchange shall discontinue the existing broadcast parameters.

Accordingly, members using NNF may note that the discontinuation date of coexistence period has been extended as below. Members shall ensure readiness of their migration plan before the extended deadline and note that there shall not be any further extension.
