Bullion

Bullion prices fell as the dollar firmed and a strong rebound in U.S. manufacturing sector fuelled hopes of a rapid recovery in the coronavirus-hit economy. The dollar rose 0.5%, further recovering from a more-than two-year low hit in the last session.

Crude oil dropped as worries about a drop in gasoline demand and data showing a surge in oil production by OPEC members weighed. Natural gas dropped on forecasts for cooler weather and lower demand for air conditioning, while a drop in liquefied natural gas exports due to the recent storms also weighed

Base Metal

Copper prices gained encouraged by buoyant U.S. moves that followed stronger-than-expected manufacturing indicators. Federal Reserve Vice Chairman Clarida said that he held open attitude to the implementation of yield curve control measures in the future, and policy makers may "adjust" the latest "economic forecast summary."

Natural Gas	Natural gas dropped on forecasts for cooler weather and lower demand for air conditioning.
Copper	Copper prices rose as investors bet on further economic recovery and also sought protection from potential inflation in commodities.
Zinc	Zinc prices dropped after disappointing U.S. payrolls numbers raised doubts about economic recovery and as the dollar firmed.
Nickel	Nickel prices gained boosted by strong demand and tightening ore supplies in China.
Aluminium	Aluminium dropped on profit booking as market sentiment and changes in inventories will be monitored.
