Crude oil dropped after diplomats said progress was made towards a deal to lift sanctions on Iran, which could boost crude supply. Natural gas slipped on a bigger-than-expected weekly storage build, a gradual increase in output and a small decline in exports.

Base Metal

Copper prices dropped as pressure seen after China's refined copper production rose 16.6% year-on-year to 901,000 tonnes in April. However upside seen limited as a softer dollar and worries about a strike in Chile spurred purchases.
