

Agri Snap shot The spices counter on the NCDEX ended with mixed node. Turmeirc ended with gains while jeera prices dropped over one and half percent and Dhaniya settled flat. Turmeric prices gained as turmeric crops were severely damaged in Parbhani and Hingoli due to heavy rains. Jeera dropped amid excess supply and as demand is likely to remain subdued on weak buying from local and overseas markets.



Top Agri Highlights

O Mentha oil prices dropped as average yield in Barabanki improved

O Cotton prices settled flat paring gains on profit booking seen earlier in the day as Chinese prices made purchasing U.S. cotton more lucrative.

O Chana prices dropped after the Centre reduced the import duty on masur dal to zero

O Turmeric prices gained as turmeric crops were severely damaged in Parbhani and Hingoli due to heavy rains.

O Jeera dropped amid excess supply and as demand is likely to remain subdued on weak buying from local and overseas markets.

O Dhaniya settled positive as arrivals in Rajkot mandi were affected as farmers were busy with sowing

O Soybean hit upper freeze of 6% as the delayed monsoon and the planting activity of soybean is adversely affected due to deficient rains in central India

O Ref soyoil prices gained supported by lingering concerns over tight supply.

O Crude palm oil gains buoyed by strong demand from top buyer India and a cut in domestic export tax reference price.
