Bullion

Gold eased as the dollar ticked up from its lows and investors showed caution in the run-up to the release of a key U.S. jobs report later in the week. Powell said tapering of the U.S. central bank's bond-buying program could happen this year but gave no indication as to the exact timeline for the Fed to start cutting its asset purchases, sending gold higher.

Energy

Crude oil prices settled flat as hurricane Ida has weakened into a tropical storm over southwestern Mississippi, the U.S. National Hurricane Center (NHC) said. Natural gas dropped on projections for lower temperatures in the immediate term, and as Tropical Storm Ida quickly weakened after making landfall on the U.S. Gulf Coast.

Base Metal

Copper prices rose amid an upbeat sentiment after U.S. Federal Reserve Chairman Jerome Powell struck a more dovish tone in a long-awaited speech. Support also seen as cancelled warrants of LME copper inventories, metals earmarked for delivery, hitting their highest since July 2020 to 84,500 tonnes.
